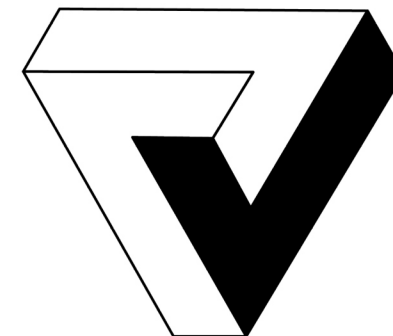

Self-sovereign Identity Solutions for Secure Digital Provenance

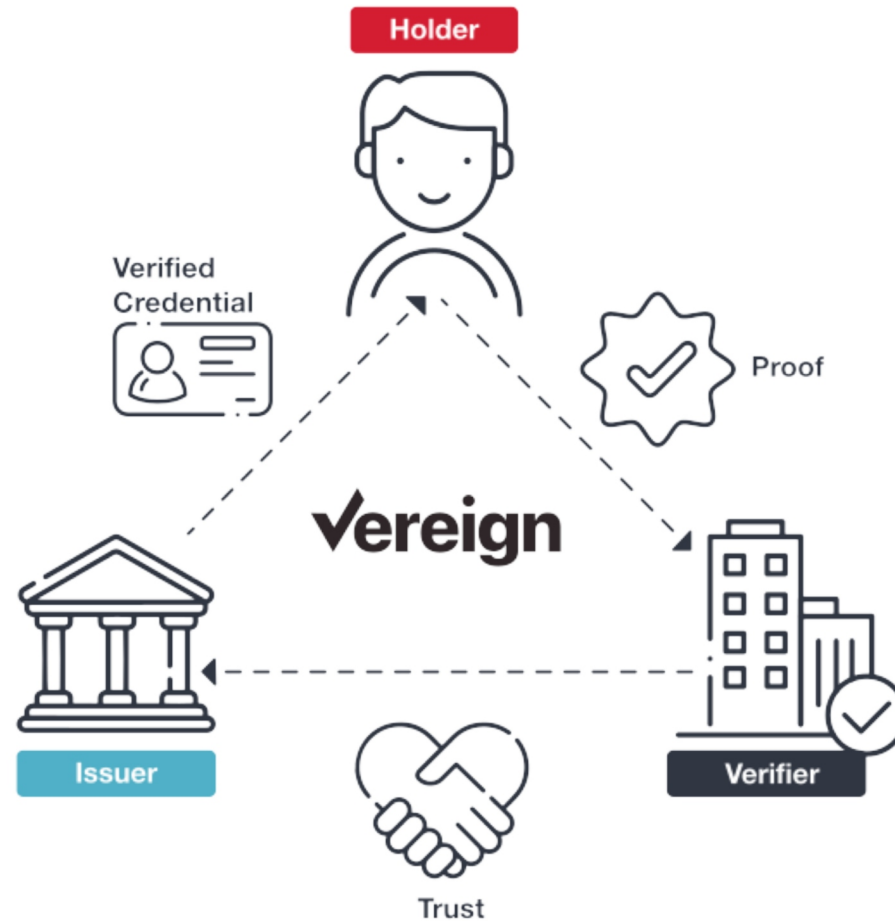
Bringing the first identity layer native to the internet to use cases, applications and organizations near you.

Every **individual** and **organization** get the sovereign power to choose who has access to what data, who to share it with, and what provider to trust to which extent.



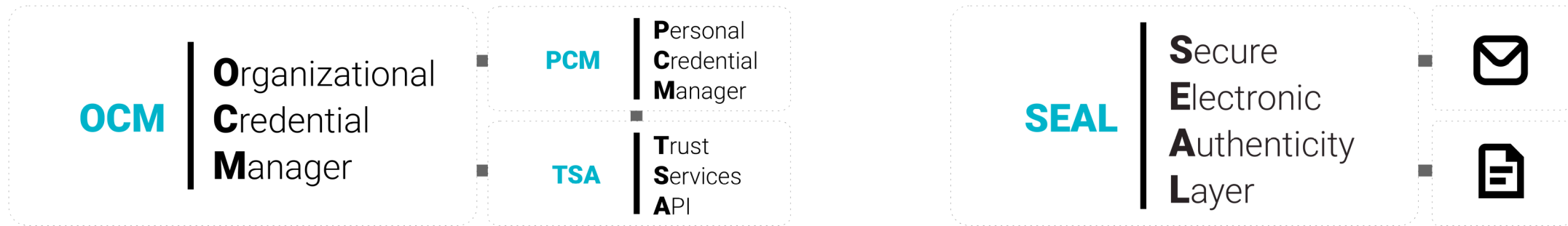
How it works

Vereign OCM is a software component that gives an Organization the capability to fully participate in the federated internet of Self Sovereign Identity, such as

- to interact with modern eID systems, i.e. for digital onboarding,
- improve online interactions and services with automated, verified data exchange,
- preparing your Organization for Zero Trust,
- providing next generation technology for qualified and advanced electronic signatures,
- issuance of Organizational diplomas or certificates, including university degrees that cannot be counterfeited
- managing security in IOT or edge computing use cases

It connects to the directory service, such as Microsoft Active directory, and can be deployed on-premise, in the cloud, or utilised in a SaaS model.

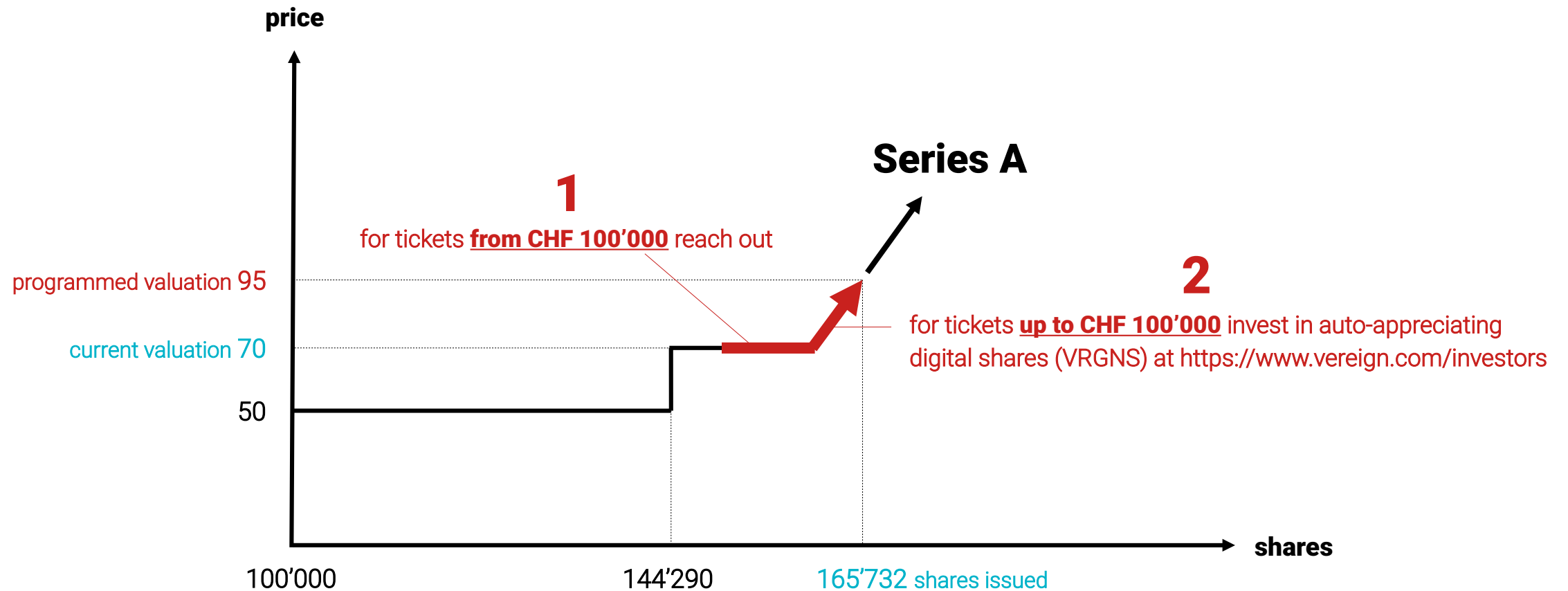
